



Whereas, **Client** desires to retain the services of **Credit Score Booster Inc.** for the purpose of helping improve **Client's** credit.

This agreement spells out the specific terms under which our company, CREDIT SCORE BOOSTER INC., hereafter «CREDIT SCORE BOOSTER INC.» will work to remove or correct on Client's credit reports negative items that are misleading, obsolete and/or inaccurate. By submitting this form Client agrees to adhere to all terms contained within this agreement.

CREDIT SCORE BOOSTER INC. makes no express or implied promises or guarantees as to the result or outcome of its services except as outlined in this agreement.

A. Services To be Provided By Credit Score Booster Inc.:

1. Initial Consultation And Work Plan

Credit Score Booster Inc. agrees to evaluate the **Client** current credit profile and will conduct the necessary steps to legally dispute information that is not accurate, complete, or verifiable. The **Client** understands that the removal of information from the credit bureau's file does not necessarily relieve the financial obligation to the creditor.

2. Scope Of Credit Services Work ("SOW")

After the initial consultation, CREDIT SCORE BOOSTER INC. will use federal and state law in the attempt to correct errors and other misleading information found in **Client's** credit reports by challenging the credit items that **Client** identifies CREDIT SCORE BOOSTER INC. as inaccurate, misleading, or unverifiable.

Credit Score Booster Inc. will perform **one** of the following work per payment cycle:

- Prepare and send disputes to the three major credit reporting agencies disputing all inaccurate negative items Client identifies
- Contact each creditor and request validation of every inaccurate negative item if necessary
- Verify unpaid collections by contacting collection agencies and requesting validation if necessary

CREDIT SCORE BOOSTER INC. will prepare all necessary correspondence in disputes of inaccurate derogatory information on **Client's** credit report. CREDIT SCORE BOOSTER INC. will update **Client** once SOW is complete.

II.

Client Agrees :

- A. Supply Smart Credit login information.
- B. Supply a detailed 3 Bureau Report from Smart Credit.
- C. Provide Client's Proof of ID and Proof of Address.
- D. Correspond and update the Credit Score Booster.**

E. That this Agreement constitutes the entire agreement between Client and Credit Score Booster Inc. and may only be modified in writing.

F. That this Agreement shall be construed and interpreted under the laws of the State of Georgia.

G. That, except as otherwise provided by law, Credit Score Booster Inc. and **Client** agree to resolve any dispute arising out of or relating to this Agreement by binding arbitration to be held in Atlanta, Georgia, by a single arbitrator to be selected jointly by the parties. The arbitrator will be empowered to determine reasonable rules relating to discovery and other procedural matters, and will be guided in such determinations by the rules of the American Arbitration Association. Judgment on the arbitration may be entered in any court with jurisdiction over the subject matter of the controversy or personal jurisdiction over the judgment debtor.

H. That, except as otherwise provided by law, if any dispute arises between parties with respect to the matters covered by this Agreement that leads to proceedings to resolve the dispute, the prevailing party in the proceeding will be entitled to recover its reasonable attorney's fees, expert witness fees, and out-of-pocket costs incurred in connection with the proceeding, in addition to any other relief that may be awarded.

I. All notices pursuant to this Agreement shall be in writing, except as provided herein, and shall be hand delivered or mailed by first class mail, postage prepared to:

B. Indemnification

Client hereby agrees to indemnify, defend and hold harmless **Credit Score Booster Inc.** and, whose credit services are provided by **therein**, its shareholders, officers, directors, employees, agents, affiliates, successors and assigns, from and against any and all claims, demands, losses, liabilities, damages or expenses (including attorneys' fees and costs) of any nature whatsoever incurred or suffered by Credit Score Booster Inc. (collectively the "Losses"), in so far as such Losses (or actions in respect thereof) arise out of, are related to, or are based on (i) any act, omission, fault, or negligence of **Client** in connection with this Agreement; (ii) the breach of any representation or warranty made by **Client** herein; or (iii) or any claim related to Credit Score Booster's site.

C. Authorization for Special Power of Attorney

Client agrees to execute an authorization that grants Credit Score Booster Inc. the right to act on **Client** behalf to contact the credit bureaus, collection agencies, financial institutions, or banks for the purposes of investigating the information that appears on **Client's** credit report. Credit Score Booster Inc. will thereby be authorized to sign all documents on **Client's** behalf for the purposes of challenging and verifying account information to all creditors and credit bureaus, including, but not limited to, requesting credit reports, and to negotiate with **Client's** creditors and collection agencies to settle any outstanding accounts **Client's** owes.

D. Right of Cancellation

You, the Client, may cancel this contract at any time prior to midnight of the fifth day after the date of the transaction.

E. Costs

Client will pay Credit Score Booster Inc. for services rendered in Section A. **Client** will supply a monthly payment.

Prime plan - \$200 a month

Upon receipt of **Client**, Credit Score Booster Inc. will invoice **Client**. **Client** will arrange payment via credit card or ACH.
